Subject: Provisional Answer Keys for JKSET/LASET (2024-25) Examination held on 07.09.2025

JKSET Agency, University of Jammu conducted JKSET/LASET examination (2024-25) on September 7th, 2025 in 41 subjects. The agency shall be uploading the Provisional Answer Keys of different subjects on the JKSET Website www.jukset.in as per the given schedule. The candidates who appeared for the JKSET/LASET Examination held on 07.09.2025 may login using their Roll No. and registered mobile number by using the link for display of the provisional answer keys. Such candidates who are not satisfied with the answer key, may challenge the same by paying a **non-refundable processing fee of ₹200/- (Rupees Two Hundred only) per question challenged** alongwith supporting documents (standard textbooks only). *The payment can be made online, through payment gateway, using Debit Card/Credit Card/Net Banking.*

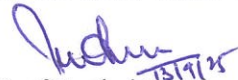
No challenge will be considered without receipt of processing fee, supporting documents and other required details. Please note that only the request for Answer Key challenge(s) made online using the link provided on the website will be considered. Challenges made through any other medium will not be entertained. The candidates are advised to take a note of this facility and act accordingly.

The Challenges made by the candidates, along with the supporting documents (standard text books only), will be verified by a panel of subject expert/s. If the challenge of any candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly. Based on the revised Final Answer Key, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The key finalized by the Experts after the challenge will be final.

Annexure – I

PROCEDURE FOR DISPLAY AND CHALLENGE OF THE ANSWER KEYS OF JKSET/LASET EXAMINATION, 7TH SEPTEMBER, 2025

1. Only the candidates who have appeared for the JKSET/LASET Exam held on September 7th 2025 alone can challenge the Answer Keys.
2. Please go to JKSET website www.jukset.in and click on the “Display/Challenge Answer Key” link. This can also be reached through JKSET/LASET page of University of Jammu website <https://jammuuniversity.ac.in>
3. Login using your Roll Number (11 digits as printed on the Admit Card) and the registered Mobile number. Your details will appear.
4. To view the Answer keys, click on the link “View Provisional Answer Key”. On the next screen click on the paper and subject to view the answer key in which you have appeared along with option to View/Download the Answer key and to register your challenge, if any.
5. After viewing the Provisional answer key. Scroll down and Click “Yes”, if you wish to challenge the answer of any question otherwise click “No” under the heading “DO YOU WANT TO CHALLENGE THE ANSWER KEY?”
6. If Yes, then enter the total no of Answers you want to challenge, in both the papers (I + II).
7. A new page will appear for Payment of Non-Refundable Processing Fee @ Rs. 200/- per answer to be challenged. Candidate has to mention the total number of Question (in both papers (I+II) and pay the fee accordingly using Credit/Debit Card/ Net Banking, as soon as your fee is accepted you get another new page to register your challenge. (Please note that, it is a Non Refundable Fee. If you have already paid the fee but unable to register your challenge due to any reason, please again fill this and click on 'Click to Pay' button. System will check the status of your payment and allow you to register your challenges).
8. On this page you have to provide following information:
 - a. Paper in which answer is to be challenged (Paper I or Paper II)
 - b. Text Booklet Series attempted (W/X/Y/Z for Paper I and A/B/C/D for Paper II)
 - c. Total number of the answers to be challenged.
9. For each answer to be challenges the candidate needs to provide following details:
 - a. Question number as per the attempted test booklet
 - b. Its correct option as per his/her claim
 - c. Remarks in favour of his/her answer in not more than 200 characters.
 - d. Furnish details of the Text Book (from which the documentary proof is being provided in favour of the answer claimed) in following format:
 - i. Title of the book
 - ii. Author (s) of the book
 - iii. Name of the publisher
 - iv. Year of Publication
 - e. Upload the documentary proof in support of your claim as a single pdf file of less than 1 MB. Please note that the documentary proof should be from a standard text book only (reference

mentioned above). Internet contents including Google, Wikipedia, News articles, Blogs shall not be taken into consideration.

(Note that the request without the above said details will not be considered at all.)

10. You can claim only on the question you attempted. In case it is found that you have not attempted the question, your claim will not be entertained.
11. After all the claims, read all the claims displayed on the screen you have made and **"Submit your claim"** if all ok.
12. Take the Print for your reference.

Important Note:

- a) These are the Provisional Answer Keys only and subject to change after the verification.
- b) Representations/request challenging the Provisional Answer Keys shall be submitted in **ONLINE MODE** only through www.jujkset.in from September 15th to September 17th 2025 only. Representations received by any other methods like Post/Courier or by Email/Fax will not be considered.
- c) The printing issue reported by the candidates regarding Set D of Economics paper is already under consideration and hence is not to be challenged through this mechanism.
- d) Representations made online after 12:00 midnight of 17.09.2025 will not be considered.
- e) Multiple challenge of same question/answer by same candidate is not allowed.
- f) All the objections / views received with evidence will be placed before the Expert Committee for finalization of the answer keys.
- g) The final answer keys will be published in the JKSET's website only after the completion of entire process along with the result.
